Jefferson County Building Commission handles occupancy permits for new construction in unincorporated areas, and the following incorporated areas: Rock Community, High Ridge, Shady Valley, Springdale, Cedar Hill, Jefferson R-7 and De Soto Rural. Otherwise, new construction in city limits go through city as required. However, Jefferson County Building Commission handles occupancy permits for cities without means of doing so.
